



Updating the National System Framework

- Published in 2008
- Sets out goals, objectives and implementation process for the National System
- Major input from MPA FAC, 2003-2007



Why update the Framework?

- Experience from implementing the national system since 2008
- Input from MPA FAC on cultural resources
- Refocused scope of MPA Center role



Major Changes

- Shortened and streamlined language
- More recognition of cultural landscape approach and tribally managed areas and resources
- More focus on functions of the national system; less on operational processes

MPA Center role focused on capacity building and

support



MPA FAC Recommendations on Cultural Heritage Resources

- New eligibility criteria for cultural heritage MPAs
 - Tribal and indigenous designations
 - Cultural landscapes
- New definition of cultural heritage (less focus solely on maritime heritage)
- New definitions of marine cultural resource, tribe, indigenous peoples and cultural landscape



 - Jointly drafted by MPA FAC and Sanctuary Advisory Council Chairs in June 2014, and independently approved by council votes this past December.

Outdoor recreation is growing rapidly throughout the U.S. and recreation along our coasts and in our ocean is no exception. To highlight the recreational opportunities created by the nation's marine protected areas (MPAs) and the need for proactive agency actions to ensure sustainable management of the natural and cultural resources that attract these visitors, the Marine Protected Areas Federal Advisory Committee (MPA FAC) and the Chairs of the National Marine Sanctuary Advisory Councils drafted a "Call to Action" in June 2014. This "Call to Action" recommends that the nation's ocean management agencies work actively with local communities to: 1) invite people to play (responsibly) in MPAs; 2) embrace the human dimension of ocean places; 3) sustain MPA ecosystems and values; and 4) engage recreational users as ocean stewards. In addition to its adoption by

the MPA FAC, the "Call to Action" is being presented to each of the 14 Sanctuary Advisory Councils for formal approval during Summer 2014. The MPA FAC also adopted **additional recommendations** on specific measures MPA managers can take to sustainably manage recreational activities.

HOME / NEWS / MPA ADVISORY GROUPS URGE SUSTAINABLE MANAGEMENT OF NATION'S OCEAN RECREATION RESOURCES

MPA advisory groups urge sustainable management of nation's ocean recreation resources

The nation's leading advisory bodies on marine protected areas are urging ocean managers to promote the recreational value of marine protected areas for travel and tourism while managing these places in a sustainable manner.

This is the first time that both the Marine Protected Areas Federal Advisory Committee and NOAA's National Marine Sanctuary Advisory Councils have collaboratively drafted and approved a joint statement regarding priority actions for ocean management. In the resulting "Call to Action," the advisory bodies assert that recreation along America's coast and in the ocean and Great Lakes is growing rapidly, and that healthy, viable marine ecosystems are fundamental to successful ocean recreation and tourism.

Sanctuary Advisory Councils Join with MPA Federal Advisory Committee on Ocean Recreation "Call to Action"

From June to November 2014, the 14 Sanctuary Advisory Councils each formally endorsed the "Call to Action" on managing recreational uses developed by the MPA Federal Advisory Committee and the Sanctuary Advisory Council Chairs at their joint meeting in June 2014. This marks the first time these MPA advisory bodies have worked together on advice for managing the nation's MPAs. The "Call to Action" calls on the nation's ocean management agencies to work with local communities to: 1) invite people to play (responsibly) in MPAs; 2) embrace the human dimension of MPAs; 3) sustain MPA ecosystems and values; and 4) engage recreational users as ocean stewards. NOAA and DOI are now looking at ways to implement these recommendations, including through the Federal Interagency Council on Outdoor Recreation.



Marine Zoning and Regulatory Review

In response to requests by members of the public, shifting environmental conditions and threats in the Keys, better scientific information, and legal requirements, Florida Keys National Marine Sanctuary is conducting a review of sanctuary regulations, including the rules and boundaries for marine zones in the sanctuary and surrounding national wildlife refuges.

The Sanctuary Advisory Council, working with public and community experts, is developing recommendations for changes to sanctuary marine zones and regulations. Using direction from
