WHY MPAS?

In the ocean, as on land, some places are more important than others. Consequently, coastal societies around the world have chosen to protect these important areas in order to sustain their ecological, cultural and economic benefits for this and future generations. Marine protected areas (MPAs) are such special places. MPAs are a resource management tool that have been used for over a century throughout US waters. Familiar examples include National Marine Sanctuaries, National Parks, National Wildlife Refuges, and their state counterparts. Creating MPAs, and managing them effectively and equitably, however, is easier said than done. The MPA Center was created to support and link MPA programs, providing the best available science and tools, as well as a means to work together to address common management challenges.

MPA CENTER MISSION AND ORGANIZATION

Established under Executive Order 13158 (May 2000), the National Marine Protected Areas (MPA) Center provides resource managers, stakeholders and other interested parties with science, technology, training and information to inform the planning and management of the nation's MPAs. This information can also support a wide range of other coastal and ocean management decisions.

How WE WORK

The MPA Center works in partnership with federal, state, tribal, and local governments and stakeholders to build a science-based, comprehensive national system of MPAs, and to support and enhance existing MPA programs across all levels of government. These collaborative efforts will


